

# Growing demand and faltering access is driving a need for innovation

Canadians are navigating increasingly complex health challenges, with chronic illnesses affecting over 40 per cent of adults<sup>1</sup> and major illness rates projected to rise 72 per cent in 15 years driven significantly by a progressively aging population.<sup>2</sup> For one third of employed Canadians, this burden is compounded by informal caregiving responsibilities, leading to absenteeism rates three times higher than non-caregivers with demands for informal caregiving expected to double in five years.<sup>3</sup>

Mental health challenges are also growing sharply. Nearly 30 per cent of Canadians experience mental illness,4 with youth particularly impacted - 19 per cent access mental health services, while another 10 per cent need help but cannot get it.5 Post-pandemic depression and anxiety rates remain 25 per cent higher than before 2020,6 with the economic cost of mental illness projected to reach \$2.5 trillion over the next two decades.7

While the need for chronic disease and mental healthcare has never been higher, Canadians are facing a crisis in access with over 5.4 million Canadians unable find a primary care provider8 and 2.5 million that can't obtain needed mental healthcare.9 Practitioners face mounting sustainability challenges and up to half of primary care providers are expected to reduce their practice within the next three years.<sup>10</sup>





# **Comprehensive mental** health support across generations


Data reveals GreenShield's mental health services resonate across generations, with 60 per cent of people using services between 25 and 44. Importantly, those over 55 contribute 10 per cent to overall utilization. Similar to international benchmarks, men's utilization is less than half that of women.<sup>38</sup> By addressing the needs of a multigenerational and diverse workforce, GreenShield's comprehensive mental health approach ensures care is accessible, inclusive, and effective for all.



# The democratization of therapy with digital CBT

With 2.5 million Canadians unable to access the mental healthcare they need, identifying effective mental health solutions that scale widely has become a health systems imperative.<sup>40</sup> Community-based primary care, which delivers 80 per cent of mental health services is severely capacity restricted. Meanwhile, the access for the 1.5 per cent of people experiencing a mental health condition who need to see a psychiatrist will also grow more difficult as the number of psychiatrists in Canada will decline by 15 per cent by 2030.41

Digital health transformation has provided purpose-built tools to democratize access to professional, evidence-based mental healthcare wherever and whenever Canadians need it. Digital Cognitive Behavioural Therapy (CBT) offers rapid support for mild to moderate stress, anxiety, and depression through self-guided or coach-supported programs. 42 Integrated within GreenShield+, digital CBT connects individuals to support anytime, anywhere.

# Mental health is personal Effective therapy is too

Optimizing the accessibility and impact of mental healthcare requires a hybrid and integrated approach that draws from a continuum of digital health guided self-care, virtual counselling and more direct care when serious and complex.44

GreenShield's individual and couples counselling focuses on personalization, autonomy, and precise matching of individuals to therapists based on their specific needs and goals. Research shows this approach enhances the experience for the individual, strengthens therapeutic relationships, increases therapy completion rates, and drives better health outcomes. 45



Using a personalized matching algorithm, GreenShield connects individuals to one of 4,000 therapists nationwide, ensuring alignment with their mental health needs, preferences, and cultural values.

This matching process helps build a strong "therapeutic alliance," a critical factor for therapeutic success. 46 Clients also have the option to meet their therapist at no cost before starting, because finding the right fit is key to meaningful progress in therapy.<sup>47</sup>

For more complex mental health challenges, consistency and continuity of care are essential. GreenShield therapists support individuals throughout their journey, transitioning seamlessly from EAP sponsored support to insurance benefits, healthcare spending accounts, or personal funds, as needed.

# A new standard in mental healthcare access

**50% of Canadians** that accessed publicly-funded community mental health counselling **waited up to 25 days** for their first session, while one in 10 faced waits of nearly five months or longer.<sup>48</sup>





# Telemedicine and health system transformation



One in six Canadians-5.4 million people-lack access to a family doctor or nurse practitioner.<sup>54</sup>

Even those with access face significant barriers to care with 40 per cent waiting four days or more for minor concerns, leading to stress, emergency department use, and avoidable illness progression.55 Younger adults are particularly affected, with 35 per cent of those aged 18-29, and nearly a quarter of those aged 30-49, without primary care.56 Combined with rising chronic disease rates and an aging population, these gaps are straining the sustainability of Canada's healthcare system.


Beyond the 2020 pandemic-era surge, telemedicine has transformed into a powerful tool that is driving healthcare innovation globally. The systematic expansion of telemedicine is now understood to be central to the performance of high-quality primary healthcare systems, 57 increasing accessibility, overall experience, and quality of care.<sup>58</sup>

GreenShield Telemedicine provides highly accessible and effective care by licensed physicians and nurse practitioners directly on the GreenShield+ platform. GreenShield Telemedicine utilization patterns reflect its impact exactly where the need is greatest for Canadians: the platform has strong adoption among younger working Canadians, with 71 per cent of individuals between 25-44 years old.

The rising prevalence of chronic diseases poses a significant challenge to individuals, communities, and economies, threatening the sustainability of healthcare systems worldwide. Addressing this burden requires accessible, intensive, and integrated care models that are adaptable to the complexities of people's lives. These models must prioritize virtual care, in-home services, and community-based solutions to effectively meet the diverse needs of individuals.

Virtual Care Teams (VCTs) are a leading model of primary care innovation that improve access, patient experience, cost efficiency, and health outcomes while advancing health equity.66

# **Empowering healthcare** through pharmacist integration

Pharmacies and pharmacists have played a pivotal role in building and shaping healthcare systems throughout Canada's history and hold a special place in GreenShield's legacy. In 1957, GreenShield was established by pharmacist William Wilkinson in Windsor, Ontario as North America's first prepaid drug plan and a non-profit social enterprise, with earnings reinvested to support Better Health for All Canadians. With over 40 per cent of Canadians experiencing chronic illness and 20 per cent using five or more medications, the integration of skilled pharmacists into healthcare teams has never been more important.68

Incorporating pharmacists into team-based care has consistently demonstrated improved health outcomes, particularly for individuals with chronic conditions such as: 69









# **Delivering high medication** adherence

GreenShield Pharmacy is transforming medication management, making it easier for individuals to access and adhere to medications.

With a simplified claims submission process, auto-fill reminders, convenient delivery, and personalized clinical consultations, GreenShield Pharmacy is not just simplifying healthcareit's making a measurable difference in health outcomes.

# Developing a new Canadian standard for electronic prior authorization

Pharmaceutical innovation has led to profound improvements in the way care is provided.

A stronger focus on the development of novel, complex therapies has led to improved outcomes for individuals living with rheumatoid arthritis, inflammatory bowel diseases (Crohn's disease/ulcerative colitis), cystic fibrosis, hepatitis C, and psoriasis.<sup>78</sup>

However, public and private payers face the dual challenge of ensuring effective access to these treatments for those in need while maintaining financial sustainability.

Prior authorization, to predetermine if a prescription drug will be reimbursed through insurance, has emerged as a critical quality-control process, ensuring treatments are used appropriately and backed by evidence and regulatory approval.<sup>79</sup>

Over the past five years, the number of medications requiring prior authorization has increased by 35 per cent.<sup>80</sup> Although this

process is an effective tool for managing complex medication therapies, it has also added administrative burdens on healthcare providers. To overcome these challenges, GreenShield is launching the **first electronic prior authorization standards process in Canada.** 

Through a partnership with OkRx and support from the Health Care Unburdened Grant program, the initiative will facilitate the integration of electronic medical records and insurance technology to transform the prior authorization process. This Grant is part of the Canadian Medical Association, MD Financial Management Inc. and Scotiabank's long-standing, joint commitment to supporting physicians and the communities they serve across Canada.

In 2024 alone, GreenShield reinvested \$12.7M and positively impacted over 300,000 individuals.84 The company is on track to reinvest \$75 million, positively impacting the lives of over one million Canadians by the end of 2025.85
